- 1. Investors are encouraged to reserve their business name with the *Registrar of Companies* prior to being registered with Investment Fiji.
- 2. If a Company/Business is listed as a Shareholder, the Application Form should include the following:
  - A certified true copy of the Certificate of Incorporation;
  - Other supporting documents such as brochures, annual reports etc (in available);
  - Name (s) of those associated with the Shareholding Company
- 3. A copy of the Shareholders Agreement and a copy of the Declaration of Shareholders, witnessed/certified by a Justice of Peace, Lawyer and/or Chartered Accountant, are to be submitted if local equity contribution is required;
- 4. A certified true copy of the Passport Bio-Data Page of all those associated with the Company/Business;
- 5. A recent (within 12 months) original or certified true copy of a Police Clearance Report from the Country of Residence of all Shareholders of the Company/Business;
- 6. Recent colour passport size photograph with names written at the back of each photograph, of all those associated with the Company/Business;
- 7. A Business Plan covering Budget/Cash Flow forecast for the proposed project;
- 8. Copies of agreement such as Lease Agreement(s), Contract Agreement(s) and Purchase Agreement(s) etc. (if any); and
- 9. Any other relevant document upon request.
- 10. Proof of company registration from abroad (if applicable) is to be provided.
- 11. The granting of a Foreign Investment Registration Certificate (FIRC) does not qualify the investor(s)/company to qualify for or be automatically granted permits from the various approving agencies.

<u>Note</u>: Under the <u>Foreign Investment Act 1999 and Foreign (Amendment) Investment Act 2004</u>, providing false and/or misleading information could incur a maximum penalty of \$20,000 and result in the cancellation of the Foreign Investment Registration Certificate (FIRC).
