I also acknowledge the efforts of the Secretariat staff and thank them for diligently working to better serve the members of the Institute.



Accreditation of the Fiji universities

Professor Denis Vinen visited Fiji in September 2017 and undertook the review of the three Fiji based universities: the University of the South Pacific, Fiji National University and University of Fiji.

Following the extensive reviews Professor Vinen recommended that all three Fiji based universities should be accredited for the same courses as had been accredited previously for a period of three years from 1 January 2018.


Professor Vinen is new FIA Accreditor

The FIA had engaged the services of Professor Denis Vinen from Swinburne University in Melbourne in succession to Professor Keith Houghton of the Australian National University in Canberra to undertake an accreditation exercise of the main tertiary institutions in Fiji from which FIA draws its members namely USP, FNU and UoF.

The FIA Council acknowledged the great

service by Professor Houghton who was the FIA accreditor from year 2010 to 2015.

FIA has since 2003 engaged the services of independent professional academics to review the quality of tertiary education being provided by those educational institutions from which the Institute principally draws its members. The latest review was conducted in 2014 and a review is done every three years.
