Most of us only see the professional side of newly elected FIA President, Renu Chand. In this issue we get a glimpse of Renu the grand-daughter, mother and wife.


Her entrepreneurial "Nani" (grandmother) was Renu's role model whilst growing up in Nadi and later in Suva.

"She was a second generation daughter of indentured labourers that came from Nepal," said Renu.

"My Nani was a child bride at the age of 10 years and did not receive an education as this was not an option. Despite the challenges, she achieved many milestones of one of which was the successful operation of a secondhand clothing shop in Nasese. She had entrepreneurial skills and vision for the start up of this second hand clothing business which is now a growing industry for SMEs in Fiji. She has always inspired me in the many qualities and her pursuit for educating her grandchildren."

After attending Nadi Airport Primary School, Renu moved to Suva with her family where she went to Suva Grammar School and later the University of the South Pacific and University of Auckland.

While still in her third year of University she was offered a position as an Economist in a global petroleum company. At a crossroads, she decided on Accounting citing career progression and financial rewards as the reason. And she has never looked back.
