# Fiji Income Tax Act Updates

#### In brief

This Bulletin includes brief details on the recent amendments made to the Fiji Income Tax Act 2015 ("FITA") in relation to exempt capital gains made by a person on the disposal of shares which the person has held from before 1 May 2011.

### In detail

Amendments made to the FITA in relation to Section 67 - Exempt Capital Gains

- Effective from 19 August 2021, the FITA will exempt from Capital Gains Tax ["CGT"] any capital gains made by a person on the disposal of shares if the shares were held by the person from before 1 May 2011 (that is, before the introduction of CGT in Fiji).
- In addition to the above, the amendments also state that where a taxpayer is required to pay CGT on the disposal of shares held by the taxpayer from before 1 May 2011 and the person has not paid the CGT to the Fiji Revenue and Customs Service (FRCS), the person is no longer required to pay the CGT and any action or suit for the recovery of the unpaid CGT immediately ceases.
- For the avoidance of doubt, the amendments also state that if a person has paid CGT before
  the effective date of the change in law on the disposal of shares held by the person before 1
  May 2011, the payment of the CGT is not refundable to the person.
