April 2022 VAT returns - due date extended

24 May 2022

The Fiji Revenue and Customs Service (FRCS) has issued a Public Notice advising of the following:

- 1. The due date for the lodgement of the April 2022 VAT returns has been extended until further notice. The late lodgement penalty will not be applicable in this period.
- 2. The VAT returns for March 2022 and the earlier months due on or before 30 April 2022 are not affected by the extension and should have already been lodged via the Taxpayer Online Service (**TPOS**) Portal.
- 3. While the due date for the lodgement of the April 2022 VAT returns has been extended, there are no changes to the due date for payment of the VAT for April 2022. Any VAT payable for the month of April 2022 should be paid by the due date (i.e. by 31 May 2022) based on your calculations. The FRCS has indicated that if there is any shortfall between the amount calculated and paid and the amount payable as per the April 2022 VAT return subsequently lodged, the FRCS will waive the late payment penalties.
